Moskvina, having considered the issue of accepting for the proceedings of the appeal of the Federal Antimonopoly Service against the decision of the Arbitration Court of Moscow. Moscow of March 19, 2013 in case No. A40-142261/2012 on the application of OJSC "Pharmstandard" (OGRN 1060274031047, 141700, Moscow region, Dolgoprudny, Likhachevsky Promenade, 5B) to the Federal Antimonopoly Service on the recognition of the decision as illegal
