DECISION on acceptance of cassation appeal to proceedings

Judge M.V. Borzykin acting on the basis of Article 18 of the Arbitration Procedure Code of the Russian Federation (in the order of interchangeability of Judge V.A.). Dolgasheva, when deciding on the issue of accepting for the proceedings of the cassation appeal of the Federal Antimonopoly Service of Russia against the decision of the Arbitration Court of Moscow of March 19, 2013, adopted by Judge I.A. Blinnikova, to the decision of the Ninth Arbitration Court of Appeal of July 12, 2013, adopted by the judges of L.A. Moskvina, E.V. Pronnikova, I.B. Tsymbarenko at the request of the Closed Joint Stock Company "Pharmstandard" (OGRN: 1060274031047, Moscow) on challenging the decision of the Federal Antimonopoly Service of Russia of 25.09.2012 in case No. 1 14.32/306-12, concerning bringing to administrative responsibility,

2 Established: The appeal was filed in compliance with the requirements provided for in Article 277 of the Arbitration Procedure Code of the Russian Federation. Guided by Article 278 of the Arbitration Procedure Code of the Russian Federation, the following DEFINITIONS: 1. Accept the cassation appeal of the Federal Antimonopoly Service of Russia to the proceedings of the court of cassation, initiate proceedings on cassation appeal. 2. To appoint a court hearing of the arbitration court of cassation instance for consideration of the cassation appeal on October 31, 2013 for 12 hours 00 minutes in the courtroom at the address: d. Moscow, st. Seleznevskaya, 9, room 6. 3. Representatives of persons participating in the case, when appearing at the court session of the court of cassation, along with the originals of powers of attorney, have their copies certified in accordance with the procedure established by law.
