DECISION on acceptance of cassation appeal to proceedings of g. Moscow 30 May 2014 Case No. A40-142261/12 Judge M.V. Borzykin acting on the basis of Article 18 of the Arbitration Procedure Code of the Russian Federation (in the order of interchangeability of Judge M.R.). Agapova) in the decision on the acceptance for the proceedings of the cassation appeal of the Open Joint Stock Company "Pharmstandard" against the decision of January 29, 2014 of the Arbitration Court of Moscow adopted by Judge I.A. Blinnikova on the decision of March 27, 2014 of the Ninth Arbitration Court of Appeal adopted by judges Zh.V. Potashova, D.E. Lepikhin, L.G. Yakovleva, on the application of the Open Joint Stock Company Pharmstandard, to challenge the decision of the Federal Antimonopoly Service to bring to administrative responsibility, has established: Whereas the appeal of cassation is filed in compliance with the requirements of Article 277 of the Arbitration Procedure Code of the Russian Federation, guided by Articles 184-188 and 278 of the same procedural law,

2 DEFINITIONS: 1. Accept the cassation complaint of the Open Joint Stock Company "Pharmstandard" to the proceedings of the arbitration court of cassation and initiate proceedings on cassation appeal. 2. To schedule a hearing on the appeal of cassation on July 3, 2014 for 10 hours and 25 minutes in the courtroom at the address: slack Seleznevskaya, d. 9, building 2, room 6, Moscow. 3. Representatives of persons participating in the case, when appearing at the court session of the court of cassation, along with the originals of powers of attorney, have their copies certified in accordance with the procedure established by law.
