DECISION on acceptance of cassation appeal to proceedings

d. Moscow 28 March 2013 Case No A40-94475/12-149-866

Judge Dolgasheva V. A., deciding on the issue of acceptance for the proceedings of the cassation appeal of the Federal Antimonopoly service (FAS Russia) against the decision of November 19, 2012 of the Arbitration court of Moscow adopted by judge Kuzin M.M., on the decision of January 31, 2013 of the Ninth Arbitration Court of Appeal adopted by judges Lepikhin D.E., Koltsov N.N., Rumyantsev P.V., at the request of Pharmstandard OJSC CJSC "ROSTA" to the Federal Antimonopoly Service (FAS Russia) on the invalidation of the decision of 25.05.2012 in case No. 1 11/202-11, a third party: Ministry of Health and Social Development of the Russian Federation,

ISSUED: The appeal was filed in compliance with the requirements provided for in Article 277 of the Arbitration Procedure Code of the Russian Federation.

2 Guided by Article 278 of the Arbitration Procedure Code of the Russian Federation, the Court

DEFINITE: Accept the cassation complaint of the Federal Antimonopoly Service (FAS Russia), initiate proceedings on cassation appeal. The court session of the arbitration court for consideration of the cassation appeal shall be scheduled for April 18, 2013 for 14 hours 55 minutes in the courtroom at the address: 127994. Moscow, GSP-4, street. Seleznevskaya, 9, building 2, ZAL 6. Representatives of persons participating in the case, when appearing at the court session of the court of cassation, along with the originals of powers of attorney, have their copies certified in accordance with the procedure established by law.
